Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, we herby inform that an unfortunate incident occurred on 12/07/2025 (Saturday) at around 8 AM, involving two of MRPL's experienced field operators. It is understood that they went on top of tank platform for checking the level of tank FB7029A in OMS area of MRPL.

Both employees were found unconscious on the tank roof top platform. They were shifted to first aid and subsequently to nearby hospital. Both these operators could not be revived and have been declared as dead.

Third operator in the rescue reported of nausea. He was admitted to the hospital in Mangalore after First aid in MRPL. He is stable and has been discharged from the hospital.

A high level committee of Group General Managers has been constituted for carrying out a detailed investigation.

We request you to kindly take the above on record.
