To The Board of Directors of Nila Infrastructures Limited

- We have reviewed the accompanying Statement of Unaudited Standalone Financial Results of Nila Infrastructures Limited (the "Company") for the quarter ended June 30, 2025 (the "Statement"). This statement has been prepared by the Company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, as amended, which has been initialled by us for identification purpose.

Pending finalisation of the appeals, the impact of these matters on the Standalone Financial Results for the quarter ended on June 30, 2025 and the adjustments (if any) required to these Standalone Financial Results, are presently not ascertainable. Our opinion is not modified in respect of this matter.

Management believes that these developments are unlikely to have a significant impact on the Company's financial position as of June 30, 2025, and its performance for the quarter ended on that date, as presented in these standalone financial results. However, due to the nature and complexity of the matter, the final outcome remains uncertain, making it currently impossible for the management to determine the potential impact, if any, on the results related to this issue. The statutory auditors have issued an Emphasis of Matter in their review report on the standalone financial results for the quarter ended June 30, 2025, highlighting this matter.
