At the same time, we'll continue growing capacities through our asset-light build-to-suit (BTS) model, maintaining flexibility and capital efficiency at the core of our strategy.

Input costs have risen in recent months, and there's naturally a time lag before price revisions catch up. This is a normal part of the operating cycle in our business, and we remain confident in our ability to balance cost pressures with sustained margins over the medium term."
