Sub: Switching-on of furnace by Impex Metal & Ferro Alloys Ltd.

Dear Sir/Madam,

We would like to inform that Impex Metal & Ferro Alloys Limited (IMPEX) (a wholly owned subsidiary of the Company), had fully close down its production by the end of April-2023 for indefinite period and intimation thereof was submitted with your Exchange vide our letter dated 2<sup>nd</sup> January, 2023 and 13<sup>th</sup> April, 2023.

We now would like to inform that IMPEX has successfully switched-on one of its two furnaces for manufacturing of Ferro-alloys on 11<sup>th</sup> November, 2025 and commercial production is expected later this month.

The other furnace is expected to be switched on within the next 5 to 7 days.

In this connection please also note that Board of Directors at its Meeting held on 28th May, 2025 had approved a Scheme of Amalgamation/Merger (the Scheme) of IMPEX with the Company and necessary sanction to the Scheme by National Company Law Tribunal is awaited.

The Furnace was switched-on, on 11<sup>th</sup> November, 2025 at 7:00 P.M. and the reason for delay in submission of disclosure is due to occurrence of event during non-working hours of the Offices of the Company.

This information is submitted pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
