We would like to inform that the Income Tax Department has filed an appeal before Honourable Madras High Court against the order of Income Tax Appellate Tribunal (ITAT) passed on 17/04/2025 for the assessment year 2015-16 for the above issue. The disputed tax value is Rs.0.48 crores. The appeal was admitted by Honourable Madras High court on 17/11/2025.

Point (f) of Annexure i.e 'Industrial promotion Assistance treated as taxable income by the income tax department instead of capital receipt'
