- A) Issued and allotted 58138 Equity Shares of Rs. 5/- each fully paid-up to eligible employees of the Company upon exercise of the Options vested with them under the Campus Activewear Limited Employee Stock Option Plan 2021 and Employee Stock Option Plan 2021 – Vision Pool. The equity shares so allotted shall rank pari passu with the existing equity shares of the Company in all respects. Below are the details of allotment:
