Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Sir / Madam,

Pursuant to Regulation 30 read with sub-para 8 of Para B of Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Master Circular No SEBI/HO/CFD/PoD2/CIR/P/0155 dated 14th November 2024, Master Circular No SEBI/HO/CFD/CFD-PoD-2/CIR/P/2024/185 dated 31st December 2024 and Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2025/25 dated 25th February 2025 issued by Securities and Exchange Board of India titled "Industry Standards Note on Regulation 30 of LODR Regulations", this is to inform the following:

We refer to our disclosure dated 20th September 2025 wherein it was informed that the Company had received a show cause notice (SCN) issued by Joint Commissioner, Central GST & Excise, Vadodara I Commissionerate proposing to levy GST amounting of Rs. 34,83,00,000/- along with applicable interest and penalty under section 74 of Central Goods & Service Tax Act, 2017 in relation to the transfer and assignment of the Company's leasehold interest in the property located at Halol, Gujarat.

In this connection, it is further informed that the Company had filed a Writ Petition challenging the aforesaid SCN before the Hon'ble Gujarat High Court. The Hon'ble High Court, following its earlier decisions on similar matters, has quashed the SCN vide its order dated 21st November 2025 (issued on 26th November 2025) ('Order').

The Order was received around 5.53 p.m. on 26th November 2025.
