- Facility of voting through poll was made available to the members who were present at the meeting and had not cast their votes by remote e-voting.

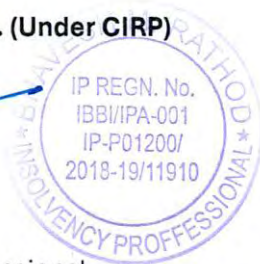
