Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Regulations"), we wish to inform you that M/s Valley Strong Cements (Assam) Limited ("Valley Strong"), a wholly owned subsidiary of M/s Barak Valley Cements Limited, has received an approval letter from the Department of Industries, Commerce and Public Enterprise, Government of Assam, Guwahati.

The said approval pertains to the proposal for granting customized incentives under the Industrial and Investment Policy of Assam (IIPA), 2019 (as amended) for the upcoming project of Valley Strong.

The project involves a **proposed investment of ₹482 Crores**, divided into two phases:

- Phase 1: ₹300 Crores
- Phase 2: ₹182 Crores

This investment is intended for the establishment of a manufacturing unit with a capacity to produce 1600 TPD clinker (Phase I), 2000 TPD cement(Phase II).

Sub: Extract of Minutes of the Cabinet Meeting held on 07.08.2025 –customized incentives to Valley Strong Cements (Assam) Ltd.

Sir,

With reference to the subject cited above, I am directed to inform here that Hon'ble Cabinet has approved the proposal for granting of customized incentives to Valley Strong Cements (Assam) Ltd., as recommended by Empowered Committee for customized under IIPA, 2019 (as amended) for the proposed investment of Rs.482 Crores (Phase 1: 300 Cr and Phase 2: Rs. 180 Cr.), as mentioned below:

i.	SGST Reimbursement: 100% reimbursement of SGST paid in cash upto 150% of eligible fixed	
	capital investment for a period of 15 Years. As the project is scheduled to be completed in two	
	phases, the validity period of the first Eligibility Certificate shall also apply to the second phase.	
ii.	Incentive for Drawl of Powerline: 50% reimbursement of cost of power drawl, subject to a	
	ceiling of Rs. 1 (one) crore,	
iii.	Road Infra: Road connectivity upto the doorstep,	
iv.	<b>Power subsidy:</b> @ Rs. 2.00 per unit consumed for a period of 5(five) years from the date	
	commercial production subject to a maximum Rs. 50 (fifty) lakhs per annum,	
v.	Interest Subsidy on Working Capital Loan: 2% interest subsidy on working capital loan for	
	five years subject to a ceiling of Rs. 50 (Fifty) lakh per annum,	
vi.	Incentives for employment generation, entrepreneurship: One-time incentive of Rs.	
	10,000 (ten thousand) to the employer against each local youth employed by the unit,	
vii.	<b>Stamp Duty Reimbursement:</b> 100% stamp duty reimbursement, subject to a monetary ceiling of	
	Rs. 25 (twenty-five) lakh,	
viii.	<b>Subsidy on Generating set:</b> @ 50% of the cost subject to a limit of Rs. 20 (twenty) lakhs	
	cost of generating set, taxes and transportation only,	
ix.	Assistance for Environmental Compliance: Subsidy @50% on capital cost for setting up of	
	effluent treatment plant subject to max of Rs. 25 (twenty-five) lakh, and	
х.	Technology Transfer and Quality Certification, ZED Certification: Subsidy up to the exte	
	of 75%, subject to a ceiling of Rs. 10 (ten) lakh.	
	Investment made on or after 1/1/2024 shall only be considered.	
	No further incentives shall be provided except as explicitly approved by the Cabinet.
