Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has received a letter from IndiaAI Mission, Ministry of Electronics and Information Technology, Government of India, regarding the **immediate allocation of GPU resources (H100 SXM and H200 SXM)** to GNANI AI, for the purpose of building India's foundational model.

As per the letter dated 2nd September 2025, H200 SXM and H100 SXM GPUs has been allocated for a period of 360 days totalling to 1,29,94,560 GPU hours. The total value for this order is approximately Rs.177 Crore (Rupees One Hundred Seventy-Seven Crore only). The GPUs are to be provided with IB network on a single fabric.

This engagement further strengthens E2E Networks Limited's positioning in the national AI infrastructure ecosystem and marks a significant step in supporting India's ambitions in AI capability building.
